WHEREAS, in an Order dated 11 November 2020 (the "Order"), the Corporate Governance and Finance Department ("CGFD") revoked Super Cash Lending Corp.'s (Super Cash) Certificate of Authority to Operate as a Lending Company (CA No. 2789) in the above-titled case;

WHEREAS, a copy of the Order was served by personal delivery to Super Cash's counsel of record, Atty. Clarence Alcorido, on 19 November 2020, in accordance with Part I, Rule IV Sec. 4-4 of the 2016 Rules of Procedure of the Securities and Exchange Commission ("2016 Rules");

WHEREAS, per records of the Commission, no appeal, motion for reconsideration, or petition for certiorari was filed within the period fixed in the 2016 Rules or The Revised Rules of Court ("Rules of Court");

WHEREFORE, in view of the foregoing, and in accordance with Part IV, Rule II, Sec. 2-4(a) of the 2016 Rules, the Order revoking the Certificate of Authority to Operate as Lending Company of Super Cash (CA No. 2789) is **FINAL AND EXECUTORY**.

Let the Order be entered in the Book of Entries of Judgments of the CGFD, in accordance with Part IV, Rule II, Sec. 2-4(b) of the 2016 Rules, in relation to Rule 36 of the Rules of Court.
