This is to inform the public that **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** is NOT AUTHORIZED TO SOLICIT INVESTMENTS FROM THE PUBLIC.

This SEC Advisory is specifically directed against the sham **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** which illegally solicits investments from the public. It is NOT in any way connected with the **OHO (OHO Marketing Ltd. and OHO Digital Marketing Agency)** companies situated and registered in the United Kingdom and the United States of America.

Based on social media (Facebook) postings, **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** started in June of 2025. It has its own Facebook page named “**OHO Tasking (Marketing Ltd.) Philippines**”. Interested persons who want to join in this platform must first register in the link: <https://ohovip.com/D28AGht>.

After registration, the recruit (investor) as shown on his board must accomplish a certain task, that is, watching in full, videos/songs and then clicking the rate button. As explained in its income chart, the investor may earn in the following manner:

- 1.) Pay a deposit of Php1,600.00 then perform five (5) tasks per day, earn Php11.00 per task, Php55.00 a day, earn Php1,650.00 per month and earn Php19,800.00 per year;
- 2.) Pay a deposit of Php4,500.00, perform ten (10) tasks, earn Php15.00 per task, earn Php150.00 per day, earn Php4,500.00 a month and earn Php54,000.00 per year. and;
- 3.) Pay a deposit of Php12800.00, perform fifteen (15) tasks per day, earn Php30.00 per task, earn Php450.00 per day, earn Php1,350.00 per month and earn Php162,000.00 a year.

At first glance, it would seem that **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** was actually offering a legitimate part-time job on a work from home basis. But in reality, there is no part-time job at all. After the recruit has completed the sign-in (registration), all he needs to do is rate a song video in its entirety, click the “finish or done” button and the task for level one is already done.” In between levels, the recruit is required to recharge (invest money) so that he can allegedly withdraw his earlier earnings.

The most common indicators of a job offer scam are the following: (1) Offering part-time jobs through unsolicited messages or invitation in social media sites; (2) promise of high returns in exchange of numerous tasks; (3) job offers are made attractive by convincing the investor of flexible working conditions; (4) Investor is required to join a group chat, usually through Viber, WhatsApp, Messenger and Telegram messaging applications; and (5) Prior to withdrawal of investment or commencement of a new task, the investor is required to pay a fee or recharge (invest money).

As stated above, **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** draws public attention through unsolicited messages in messaging platforms or invitation of job opportunities through Facebook. Commensurate to the work offered by **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** is the promise of high monetary return “that is too good to be true”. **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** assures its member of no risk of losing money but instead guarantees high return of investment without exerting much time, least effort or no effort at all from

the member himself. Simply watch a video, once you are done, you earn money. The member is also promised not to work under pressure considering that he need not work on an eight-hour work arrangement. He is also obliged to join a group chat for the group's regular weekly meeting. This group chat serves as venue for the announcement of supposed bonuses to be received. And lastly, after the tasks are completed, the recruit is obliged to recharge or invest money before he could withdraw his earnings.

However, the recruit is not able to withdraw his earnings but is tricked into paying more money as a condition for release of earnings, which never happens, until the recruit realizes that he has been scammed or duped. It is only at the beginning of the scheme that the recruit is allowed to withdraw earnings from small initial investments to trick them into believing that the scam is legit.

The above described modus used by these scammers are pseudo "JOB SCAMS or TASKING" & "RECHARGING SCAMS" with supposed investment in an enterprise where the recruit is made to believe he has been recruited to join and perform menial tasks which require him to make an investment before they can perform the task and earn.

The investment commonly used to entice recruits is in the form of an "*investment contract*" which exists when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived from the efforts of others which is prominent in the scheme of **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** together with its TASKING & RECHARGING SCAM.

The Securities Regulation Code (SRC) requires that offer and/or sale of securities must be duly registered with the Commission and that the concerned entity and/or its agents should have the appropriate registration and/or license to sell such securities to the public.

Based on the Commission's database, **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** is **NOT REGISTERED** as a corporation or partnership and **OPERATES WITHOUT THE NECESSARY LICENSE AND/OR AUTHORITY to solicit, accept or take investments/placements from the public nor to issue investment contracts and other forms of securities defined under Section 3 of the Securities Regulation Code (SRC).**

Moreover, the Financial Products and Services Consumer Protection Act prohibits the commission of "Investment fraud", defined as any form of deceptive solicitation of investments from the public which includes Ponzi schemes and such other schemes involving the promise or offer of profits or returns sourced from the investments or contributions made by the investors themselves and the offering or selling of investment schemes to the public without a license or permit from the SEC.

In view thereof, the public is hereby warned to STAY AWAY FROM OFFERS OF PART-TIME JOBS USING THE TASKING & RECHARGING SCHEME and NOT TO INVEST

or to STOP INVESTING in the conjoined investment scheme being offered by **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)** as well as to any other entities having the same or similar schemes and to exercise caution in dealing with any individuals or group of persons soliciting investments or recruiting investors for and on behalf of **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)**.

Those who act as salesmen, brokers, dealers or agents, representatives, promoters, uplines, recruiters, influencers, endorsers and enablers of **OHO/OHO MARKETING LTD/OHO Tasking (Marketing Ltd.)**, in selling or convincing people to invest in the investment scheme being offered by the said entity including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the Financial Products and Services Consumer Protection Act (FCPA) and under Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).
