

ADVISORY

This Advisory is prompted by inquiries, reports and information received by the Commission that a certain entity named **ADSCENT INTERNATIONAL**, through its owner **Vinroge Torre** is enticing the public to invest their money in the said entity for a promise of high monetary rewards or profits.



Based on the reports, **ADSCENT INTERNATIONAL** and its CEO **Vinroge Torre** through Facebook, with its agents, is collecting funds from the public or supposed investments and business loans for a promise of receiving 120%, 350%, and 300% revenue for a period of 7, 20 and 15 days, respectively given that the task given is complied. They can also earn an extra 10% of the total investment of their referral.

Investors may register through their website at <http://adscentlabs.com/> or join different Facebook groups that is managed by the team leaders to manage their investments and serve as their adviser in future transactions.

As seen in the social media postings and offerings in the social media accounts of the members of **Adscent International**, it was stipulated that the investor shall choose from the three investment plans of the company (**ADSCENT INTERNATIONAL**) with different profit margin equivalent to different minimum and maximum investments. Below are the screenshot copies of the said Investment plans and its stipulations which was presented to the Commission:

Hence, the Securities Regulation Code (SRC) requires that these securities must be duly registered and that the person and/or agents selling or offering it for sale must have the appropriate registration and/or license to sell such securities to the public pursuant to Section 8 and 28 of the SRC.

Briefly, an Investment Contract exist when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived primarily from the efforts of others which is prominent in the scheme being employed by **ADSCENT INTERNATIONAL**, through its owner ***Vinroge Torre and its members***.

The public is hereby informed that **ADSCENT INTERNATIONAL** is **not authorized to solicit investments** from the public, not having secured prior registration and/or license to sell securities or solicit investments as prescribed under Section 8 of the Securities Regulation Code (SRC).

Likewise, ***Vinroge Torre*** has not been issued a Certificate of Registration as a registered Associated Person, Compliance Officer, Salesman and/or Certified Investment Solicitor of a Broker Dealer in Securities Investment, Investment House, Underwriter of Securities, Investment Company Adviser, and/or Mutual Fund Distributor.

Further, those who act as salesmen, brokers, dealers or agents, representatives, promoters, recruiters, uplines, influencers, endorsers, abettors and enablers of **ADSCENT INTERNATIONAL** and its owner **Vinroge Torre** in soliciting or convincing people to invest in the investment scheme being offered by **ADSCENT INTERNATIONAL** including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the FCPA and Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty-One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).
