

**INVITATION TO BID FOR
Supply and Delivery of Catering and Others Services for the SEC Year-End
Assembly 2025**

- 1) The Securities and Exchange Commission (SEC), through the FY 2025 Annual Operating Budget for SEC, intends to apply the sum of **Three Million One Hundred Fifty Thousand Pesos (Php3,150,000.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Catering and Other Services for the SEC Year-End Assembly 2025**, under **Competitive Bidding No. 2025-038**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The SEC now invites bids for procurement Project. Delivery of the Goods is required in FY 2025 as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, at least within five (5) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from the SEC and inspect the Bidding Documents at the address given below from 7:00AM to 4:00PM.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on 07 November 2025 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php2,500.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The prospective bidders are advised to send an email at fpbaluyot@sec.gov.ph to request for the Payment Assessment Form (PAF), which shall be used for the payment of the abovementioned applicable fee.

Payments should be done over the counter at any Landbank branch nationwide or online through eSPAYSEC.

- Present On-Coll Payment Slip, together with the PAF, to the LandBank Teller

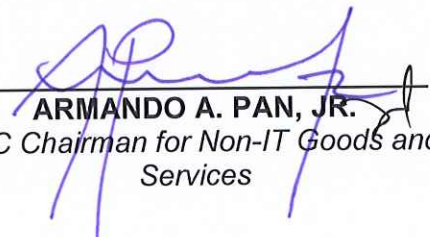

- 6) The SEC will hold a Pre-Bid Conference on **14 November 2025 (Friday), 11:00AM** at the MSD Conference Room, 7F The SEC Headquarters, 7907 Makati Ave., Salcedo Village, Bel-Air, Makati City and through video conferencing via Zoom application, which shall be open to prospective Bidders.
 - 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below on or before **28 November 2025 (Friday), 11:00AM**. Late bids shall not be accepted.
 - 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
 - 9) Bid opening shall be on **28 November 2025 (Friday), 11:15AM** at the MSD Conference Room, 7F The SEC Headquarters, 7907 Makati Ave., Salcedo Village, Bel-Air, Makati City and via Zoom application. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
 - 10) The SEC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
