League of Seagull Ltd. claims to be headquartered in **Colorado, United States of America**, and to have been registered on **3 September 2024**, supported by certificates and documents. It further claims to be expanding its operations in the Philippines and uses such representations to imply that allegations of fraudulent or scam investment activities are unfounded. Despite these claims, the entity continues to promise **unusually high investment returns** while operating **without the required registration and license from the Commission**.

Records from the **Office of the Secretary of State of the State of Colorado** show that **League of Seagull Ltd.**, with Entity ID No. **20241936415**, filed its Articles of Incorporation in said jurisdiction and lists **Ernest Dewey May Jr.** as its amended registered agent, replacing its previous registered agent, **Fong Sam International Accounting Firms**, appears in public records in relation to **BG Wealth Sharing LTD**.

League of Seagull Ltd. is allegedly operated by a group of individuals based in the United States of America, identified as follows: **Charles Hamilton** (Leader), **Martin Collins** (Technology), **David Morley** (Trade Signal Watcher), **Patrick Iqbal** (Compliance), **Olivia Coffman** (Marketing and Recruitment), **Margaret Alston** (Marketing and Recruitment), **Alisana Miller** (Operations), and **Annabell** (Operations).



In **Pangasinan**, the entity reportedly operates through a local group known as **Team Bagwis Payaman**, led by **Shane Disepeda Dollente**, also known as **Leader Shane**. This group is allegedly responsible for promotional and recruitment activities conducted online and through an office operating under the name **Seagull Alliance Clothing** located at the **Bayanihan Bank Building, Rizal Street, Poblacion District II, Pozorrubio, Pangasinan**, with the tagline “A starting point for a dream of your kids to take off.”

Additionally, **League of Seagull Ltd.** has expanded its operations in the Philippines beginning **19 September 2024**. As of the date of assessment, the gathered social media presence and places of operation cover multiple regions nationwide, as follows:

Violators may be penalized with a **fine of not more than Five Million Pesos (PHP 5,000,000.00)** or **imprisonment of not more than Twenty-One (21) years** or **both** under **Section 73 of the SRC**.
