Based on information received by the Commission, **MTSN INTERNATIONAL OPC, LEX FRANCHISING SOLUTIONS OPC, LEVEX INTERNATIONAL OPC**, all represented by **Alexander Gabayno San Carlos** as its sole incorporator with **Meriel "Jhun" Clores Serdan, Elmer Gabayno** and **Verlan "Lanz" Moreno Enrile** as his business partners; and **Shirley "Shen" Nollado** as an agent and representative of **LEX FRANCHISING, MTSN** and **LEVEX** as their Franchise Account Officer are inviting the public to invest in said entities.

The aforesaid corporations present itself as businesses engaged in "the importing, trading, and marketing of milk tea products", "to provide food service and in relation thereto to enter into franchising agreement and marketing thereafter", and "to engage in trading and marketing of beauty, health and wellness products" respectively. These entities are inviting the public to invest their money in the abovementioned entities by operating the following Facebook pages:

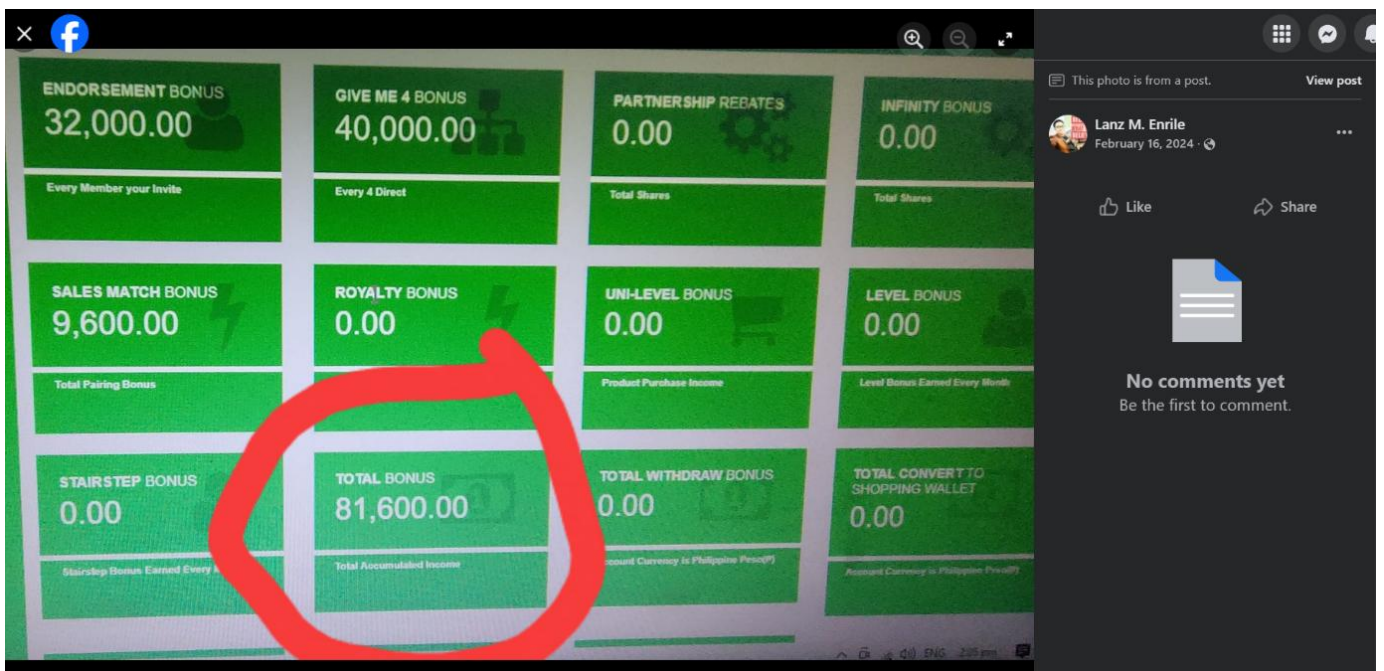

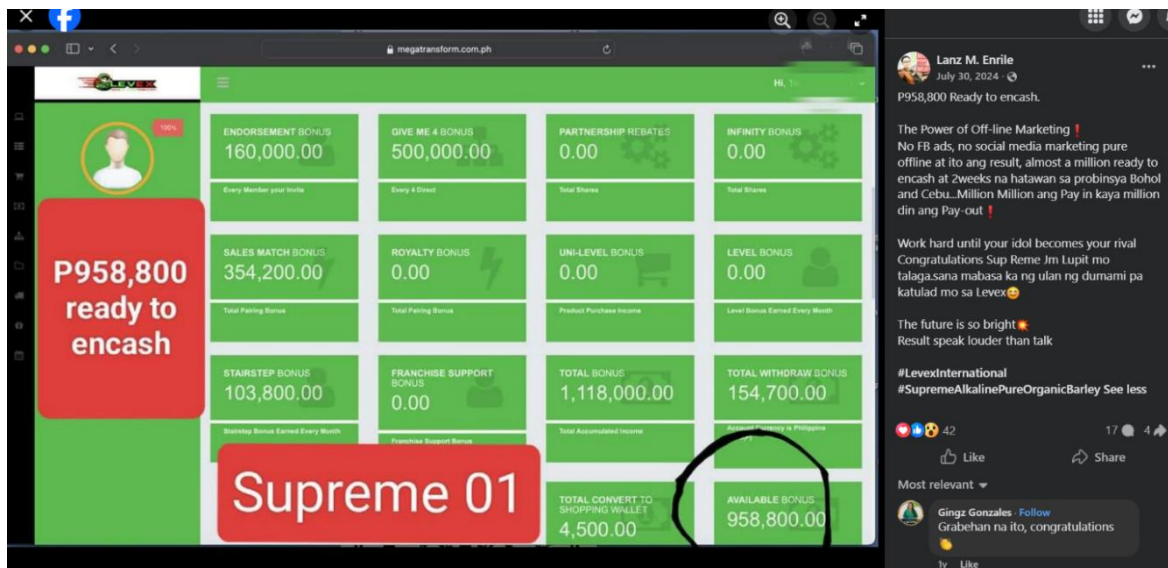

It is evident that the business of distributing the aforesaid barley products is closely intertwined with the operations of **LEVEX INTERNATIONAL**. Apart from offering package deals for the distribution of pouches of the barley drink, **Verlan "Lanz" Moreno Enrile** induced the public to participate in this scheme by uploading screenshots of a dashboard showing the large amount of profits one may earn, including an endorsement bonus which depend on the number

Briefly, an "investment contract" exists when there is an investment or placement of money in a common enterprise with reasonable expectation of profits to be derived from the efforts of others, which is apparent on **LEX FRANCHISING, MTSN** and **LEVEX**'s schemes. Therefore, all the aforesaid corporations must first be duly registered with the Commission and that any person or entity intending to sell or offer investment contract are required to secure the necessary registration and/or license from the Commission as well.

Furthermore, Republic Act No. 11765 or the Financial Products and Services Consumer Protection Act (FCPA) also prohibits investment fraud which is defined under the law as any form of deceptive solicitation of investments from the public which includes Ponzi Schemes and such other schemes involving the promise or offer of profits or returns sourced from the investments or contribution made by the investors themselves and the offering or selling of investment schemes to the public without a license or permit from the SEC.

As per our records, **LEX FRANCHISING, MTSN** and **LEVEX** are all **REGISTERED** with the Commission as a corporation or partnership, however, they are **NOT AUTHORIZED** to solicit investments from the public, not having secured prior registration and/or license to sell securities or solicit investments as prescribed under Section 8 of the Securities Regulation Code (SRC).

In view thereof, the public is hereby advised **NOT TO INVEST** or to **STOP INVESTING** in the scheme being offered by **LEX FRANCHISING, MTSN** and **LEVEX** or its representatives.

Those who act as salesmen, brokers, dealers or agents, representatives, promoters, recruiters, uplines, influencers, endorsers, abettors and enablers of **LEX FRANCHISING, MTSN** and **LEVEX** in soliciting or convincing people to invest in the investment scheme being offered by the said entity including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the FCPA and Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php 5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC.**

Finally, those who invite or recruit others to join or invest in such venture or offer securities to the public may incur criminal liability, or otherwise be sanctioned or penalized accordingly as held by the Supreme Court in the case of *Securities and Exchange Commission v. Oudine Santos* (G.R. No. 195542, 19 March 2014).
