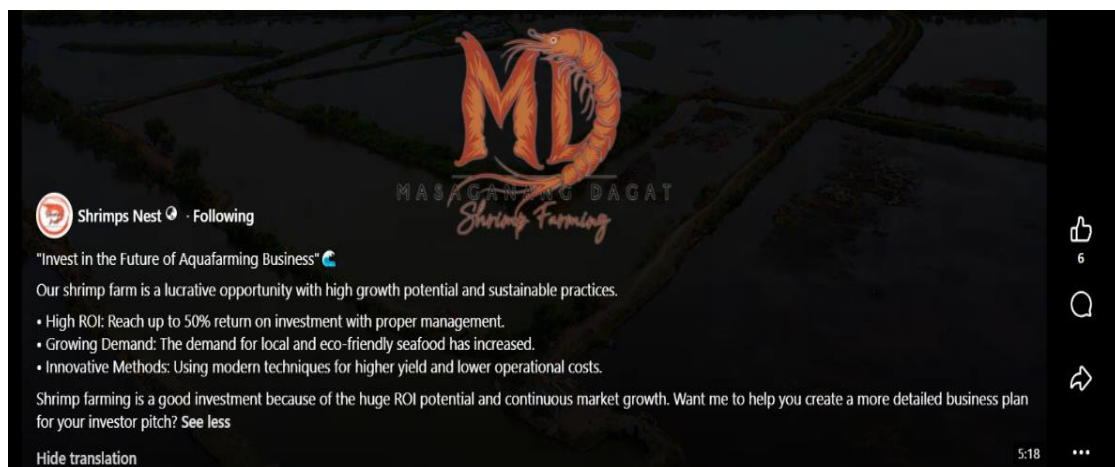
This is to inform the public that MASAGANANG DAGAT OPC/MASAGANANG DAGAT-AQUA FARM/MASAGANANG DAGAT SHRIMP FARMING, is NOT AUTHORIZED TO SOLICIT INVESTMENTS FROM THE PUBLIC.

LEONARD COSINO TAMAYO, promoter of **MASAGANANG DAGAT OPC/MASAGANANG DAGAT-AQUA FARM/MASAGANANG DAGAT SHRIMP FARMING (MASAGANANG DAGAT for brevity)** utilized the Facebook social media through the *Masaganang Dagat-Shrimp Farm* Facebook page <https://www.facebook.com/Masaganang.Dagat> for the advancement of its operations.

In one of his Facebook videos (Facebook Reels, through the link <https://www.facebook.com/reel/689110980926337> Mr. Tamayo invited and encouraged the public to invest in his shrimp farm. Accordingly, the investor need not do anything as he shall personally raise the shrimplets (shrimp fry), manage the shrimp farm and sell the same in the market.

*An investor for **MASAGANANG DAGAT** may earn in three possible ways, to wit:*

- (1.) Investment for three (3) months – for a minimum investment of Php 3,000.00 pesos, an investor may earn up to 40% or equivalent to Php 4200.00 pesos;*
- (2.) Investment for nine (9) months – for a minimum investment of Php 3,000.00 pesos, an investor may earn up to (more or less) 37% or equivalent to Php 9,600 pesos; and*
- (3.) Weekly Investment – for a minimum investment of Php 3,000.00 pesos, an investor may earn up to 3 % or Php 5,250.00 (in 25 weeks).*

Briefly, an “*investment contract*” exists when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived from the efforts of others which is prominent in the scheme of **MASAGANANG DAGAT**.

As such, the Securities Regulation Code (SRC) requires that said offer and/or sale of securities must be duly registered with the Commission and that the concerned entity and/or its agents should have the appropriate registration and/or license to sell such securities to the public.

Based on the Commission’s database, **MASAGANANG DAGAT OPC** is a **REGISTERED** stock corporation. However, it **OPERATES WITHOUT THE NECESSARY LICENSE AND/OR AUTHORITY to solicit, accept or take investments/placements from the public nor to issue investment contracts and other forms of securities defined under Section 3 of the Securities Regulation Code (SRC).**

Moreover, the Financial Products and Services Consumer Protection Act prohibits the commission of “Investment fraud”, defined as any form of deceptive solicitation of investments from the public which includes Ponzi schemes and such other schemes involving the promise or offer of profits or returns sourced from the investments or contributions made by the investors themselves and the offering or selling of investment schemes to the public without a license or permit from the SEC.

In view thereof, the public is hereby advised **NOT TO INVEST** or to **STOP INVESTING** in the investment scheme being offered by **MASAGANANG DAGAT OPC/ MASAGANANG DAGAT-AQUA FARM/MASAGANANG DAGAT SHRIMP FARMING** as well as to any other entities having the same or similar schemes and to exercise caution in dealing with any individuals or group of persons soliciting investments or recruiting investors for and on behalf of **MASAGANANG DAGAT**.

Those who act as salesmen, brokers, dealers or agents, representatives, promoters, uplines, recruiters, influencers, endorsers and enablers of **MASAGANANG DAGAT**, in selling or convincing people to invest in the investment scheme being offered by the said entity including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the Financial Products and Services Consumer Protection Act (FCPA) and under Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).

Furthermore, the names of all those involved will be reported to the Bureau of Internal Revenue (BIR) so that the appropriate penalties and/or taxes be correspondingly assessed.
