

PUBLIC ADVISORY

ON THE UNAUTHORIZED USE OF THE COMPANY NAME OF ACOM CONSUMER FINANCE CORPORATION BY FAKE FACEBOOK PAGES

The Securities and Exchange Commission (“SEC” or “Commission”) hereby warns the public against certain Facebook pages that have been reported to be unlawfully using and impersonating the name, corporate identity, and promotional materials of ACOM CONSUMER FINANCE CORPORATION (“ACOM” or the “Company”) in connection with the offering or promotion of loan products and related financial services.

The Company reported to the Commission that the subject Facebook pages falsely represent themselves as being connected with, affiliated with, authorized by, or acting on behalf of ACOM.

Based on the information and supporting documents submitted to the Commission, the subject Facebook pages allegedly use the Company's name, logo, office address, promotional materials, and other identifying information to create the false impression that they are legitimate representatives of the Company.

The Company has expressly denied any ownership, operation, control, authorization, endorsement, affiliation, or other connection with the subject Facebook pages.

For complaints, reports, or verification requests, the public may contact the SEC through the following official Documents submitted to the Commission further indicate that certain individuals operating through the subject Facebook pages may be soliciting prospective borrowers and requesting purported membership fees, processing fees, and similar payments in connection with loan applications while representing themselves as connected with ACOM.

The public is reminded that the unauthorized use of the name, identity, or regulatory information of a duly registered financing company may be employed to mislead consumers, facilitate fraudulent transactions, obtain personal information, or induce payments under false pretenses.

Accordingly, the public is strongly advised to:

- Exercise extreme caution when dealing with social media pages claiming to represent financing or lending companies;
- Refrain from sending money, membership fees, processing fees, insurance fees, verification fees, or similar payments based solely on representations made through social media;

- Avoid providing personal, financial, or sensitive information through unverified online accounts or communication channels; and
- Independently verify the authenticity of financing companies and their official channels before entering into any financial transaction.

Any person who may have been contacted by, solicited by, or transacted with the subject Facebook pages is encouraged to immediately report the matter to the SEC and other appropriate authorities and preserve all available evidence, including screenshots, receipts, transaction records, and communications.
