

PUBLIC ADVISORY

ON THE UNAUTHORIZED USE OF THE NAME, CORPORATE IDENTITY, AND REGULATORY CREDENTIALS OF MABILIS CASH FINANCING CORP.

The Securities and Exchange Commission ("SEC" or "Commission") hereby warns the public against several Facebook pages, TikTok accounts, websites, and mobile applications that have been reported to the Commission for allegedly using, without authority, the name, corporate identity, registration details, and regulatory credentials of MABILIS CASH FINANCING CORP. ("Mabilis Cash" or the "Company") in connection with the offering, promotion, or facilitation of loan products and related financial services.

According to information submitted to the Commission, the following Facebook pages have represented themselves as connected with, affiliated with, endorsed by, or authorized by Mabilis Cash:

Based on the representations made by the Company and the verification conducted by the Financing and Lending Companies Department (FinLenD), the foregoing Facebook pages, TikTok accounts, mobile applications, and websites are not owned, operated, controlled, authorized, endorsed, or

affiliated in any manner with MABILIS CASH FINANCING CORP. The Company has expressly denied any connection or association with the foregoing platforms.

The Commission reiterates that only financing companies and lending companies duly registered with the SEC, and operating through properly disclosed and recorded Online Lending Platforms, are authorized to engage in online lending activities under applicable laws, rules, and regulations.

The unauthorized use of the name, corporate identity, registration details, or regulatory credentials of a duly registered financing or lending company may mislead consumers and expose them to fraudulent schemes, unauthorized collection of payments, identity theft, misuse of personal information, and other forms of financial or cyber-enabled fraud. Such acts may likewise constitute violations of existing laws, including the Financing Company Act of 1998, the Lending Company Regulation Act of 2007, the Financial Products and Services Consumer Protection Act, the Electronic Commerce Act, the Cybercrime Prevention Act of 2012, and other applicable laws, rules, and regulations.

Accordingly, the public is strongly advised NOT to transact with, provide personal or sensitive information to, download applications from, or make payments through the foregoing Facebook pages, TikTok accounts, mobile applications, websites, or any other platform claiming to represent Mabilis Cash unless independently verified through the Company's official channels and the records of the Commission.

Any person who may have been solicited by, contacted by, or who has transacted with any of the foregoing platforms is encouraged to immediately report the matter to the SEC and the appropriate law enforcement agencies.

The Commission remains steadfast in its commitment to protect financial consumers and the general public against unauthorized, deceptive, and unlawful lending activities conducted through online and digital channels.
