

ADVISORY

This Advisory is prompted by inquiries, reports and information received by the Commission that a certain entity named **EAGLE'S ONE MARKETING CORP** is enticing the public to invest their money in the said entity for a promise of high monetary rewards or profits.



Based on the reports, **EAGLE'S ONE MARKETING CORP** is soliciting investment from the public through their social media platform, specifically via her facebook page and thru their website <https://eaglesonemarketing.com/>.

It was further reported that to join the entity **EAGLE'S ONE MARKETING CORP.** potential investors are offered to buy health and wellness products coupled with referral based income venture, once the latter is fulfilled they may now avail the lock in program investment with 3 months and 6 months compounding interest for a promise of receiving a guaranteed monthly return of 93%, with a minimum starting capital of 1,500 which may earn 3,250 in 3 months and 7,240 in 6 months and a maximum of 1,000,000 which may earn 2,197,000.00 in 3 months and 4,825,809.00 in 6 months.

In the meetings held by, **EAGLE'S ONE MARKETING CORP.**, it is inviting its members to join the **EAGLE'S ONE POOL FUNDING PLAN**, to wit:

Notably, the above described scheme involves the offering and sale of securities to the public in the form of an *"Investment Contract"*. Hence, the Securities Regulation Code (SRC) requires that these securities must be duly registered and that the person and/or agents selling or offering it for sale must have the appropriate registration and/or license to sell such securities to the public pursuant to Section 8 and 28 of the SRC.

Briefly, an Investment Contract exist when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived from the efforts of others which is prominent in the scheme being employed by **EAGLE'S ONE MARKETING CORP.**

Further, based on the records of the Commission, **EAGLE'S ONE MARKETING CORP.**, is registered with the Securities and Exchange Commission (SEC) under Company Registration No. 2025050203246-03. However, such Certificate **does not authorize investment solicitation and investment-taking without a secondary license from the Commission.**

Likewise, the owner and CEO of **EAGLE'S ONE MARKETING CORP.**, **JESSIE RELOX ROYO** have not been issued Certificate of Registration as registered Associated Person, Compliance Officer, Salesman and/or Certified Investment Solicitor of a Broker Dealer in Securities Investment, Investment House, Underwriter of Securities, Investment Company Adviser, and/or Mutual Fund Distributor.

Further, those who act as salesmen, brokers, dealers or agents, representatives, promoters, recruiters, uplines, influencers, endorsers, abettors and enablers of **EAGLE'S ONE MARKETING CORP.** in soliciting or convincing people to invest in the investment scheme being offered by **EAGLE'S ONE MARKETING CORP.** including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the FCPA and Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).
