

SEC ADVISORY

This is to inform the public that ECOCAPSULE, is NOT AUTHORIZED TO SOLICIT INVESTMENTS FROM THE PUBLIC.

This Advisory is **NOT** in any way connected with the **ECOCAPSULE** European based company engaged in futuristic egg-shaped micro-unit houses, cottages, mobile office and research station utilizing solar and wind energies.

Through its promoters, this fake **ECOCAPSULE** platform used the Facebook social media platform for the advancement of its operations.

An Investor may earn in **ECOCAPSULE** in the following ways:

- 1.) After registration in the link https://www.ecocapsule.cc/#/?invite_code=evN6dA, an investor automatically receives P20 Php in his **ECOCAPSULE** wallet.
- 2.) Recharge (deposit) and payment is made through Gcash.
- 3.) **ECOCAPSULE** has two investment plans, namely “mini” and “large” level plans:
 - a.) The minimum investment is Php 781.00. The **mini level** has a special price beginning at Php 0.00 with a Php 1.50 hourly income or a total of Php 1,260.00 under a thirty-five (35) day cycle;
 - b.) The maximum hourly income under this level amounts to Php 1,212.08 with a total of Php 174,643.02 under a sixty (60) day cycle;
 - c.) The **large level** starts at a Php 204.00 daily income or Php 10,200.00 total income under a fifty (50) day cycle;
 - d.) The maximum daily income under this level is Php 43,411.02 or a total income of Php 347,298.06 under an eighty (80) day cycle;

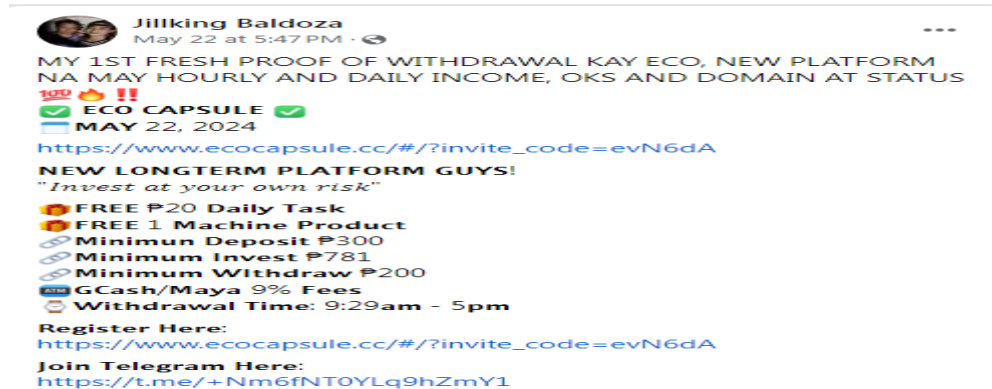

Briefly, an “*investment contract*” exists when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived from the efforts of others which is prominent in the scheme of **ECOCAPSULE**.

As such, the Securities Regulation Code (SRC) requires that said offer and/or sale of securities must be duly registered with the Commission and that the concerned entity and/or its agents should have the appropriate registration and/or license to sell such securities to the public.

Based on the Commission’s database, **ECOCAPSULE**, is **NOT REGISTERED** as a corporation or partnership and **OPERATES WITHOUT THE NECESSARY LICENSE AND/OR AUTHORITY to solicit, accept or take investments/placements from the public nor to issue investment contracts and other forms of securities defined under Section 3 of the Securities Regulation Code (SRC).**

The scheme employed by, **ECOCAPSULE** has the characteristics of a “**Ponzi Scheme**” where money from new investors are used in paying “fake profits” to prior investors and is designed mainly to favor its top recruiters and prior risk takers and is detrimental to subsequent members in case of scarcity of new investors.

The offering and selling of securities in the form of investment contracts using the “**Ponzi Scheme**” is fraudulent and unsustainable.

Moreover, the Financial Products and Services Consumer Protection Act prohibits the commission of “Investment fraud”, defined as any form of deceptive solicitation of investments from the public which includes Ponzi schemes and such other schemes involving the promise or offer of profits or returns sourced from the investments or contributions made by the investors themselves and the offering or selling of investment schemes to the public without a license or permit from the SEC.

In view thereof, the public is hereby advised **NOT TO INVEST** or to **STOP INVESTING** in the investment scheme being offered by **ECOCAPSULE** as well as to any other entities having the same or similar schemes and to exercise caution in dealing with any individuals or group of persons soliciting investments or recruiting investors for and on behalf of **ECOCAPSULE**.

Those who act as salesmen, brokers, dealers or agents, representatives, promoters, uplines, recruiters, influencers, endorsers and enablers of **ECOCAPSULE**, in selling or convincing people to invest in the investment scheme being offered by the said entity including soliciting investments or recruiting investors through the internet may

be held criminally liable under Section 11 of the Financial Products and Services Consumer Protection Act (FCPA) and under Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).

Furthermore, the names of all those involved will be reported to the Bureau of Internal Revenue (BIR) so that the appropriate penalties and/or taxes be correspondingly assessed.
